ORDINANCE 11-2003

A Petition For Annexation under oath having been presented to the Mayor and City

Council of the City of Athens, in which Petition the record owners have joined in writing,

requesting annexation of territory not now within the corporate limits but contiguous to the City

of Athens, Illinois, which territory is described as follows:

Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47 and 48 of the subdivision known as Barn Hollow Estates recorded February 11, 1998 as Document #158912, Book 438, Page 147, and in Plat Cabinet B, Page 60 in the Menard County Recorder's Office, said subdivision known as Barn Hollow Estates is more particularly described as follows:

Part of the Northeast quarter of Section 2, Township 17 North, Range 6 West of the Third Principal Meridian, described more particularly as follows:

Commencing at a found iron pin marking the Northwest corner of the Northeast Quarter of the aforementioned Section 2, thence South 89 degrees 31 minutes 46 seconds East along the section line a distance of 406.88 feet measured (407.03 feet plat) to a found iron pin marking the true point of beginning, thence continuing South 89 degrees 31 minutes 46 seconds East along the section line a distance of 110.50 feet to a mag nail, thence South 00 degrees 28 minutes 14 seconds West a distance of 184.00 feet to an iron pipe, thence South 89 degrees 31 minutes 46 seconds East a distance of 237.00 feet to an iron pipe, thence North 00 degrees 28 minutes 14 seconds East a distance of 184.00 feet to a mag nail on the section line, thence South 89 degrees 31 minutes 46 seconds East along the

section line a distance of 139.34 feet to a P.K. nail, thence South 00 degrees 40 minutes 19 seconds East along an existing fence line and agreed to property line a distance of 1472.22 feet to an iron pipe, thence North 89 degrees 53 minutes 57 seconds East a distance of 81.86 feet to an iron pipe, thence South 00 degrees 54 minutes 57 seconds East along an existing fence line and agreed to property line a distance of 727.72 feet to a found iron pin, thence South 69 degrees 47 minutes 42 seconds West a distance of 566.94 feet to a found iron pin, thence North 72 degrees 41 minutes 46 seconds West a distance of 486.06 feet to a found iron pin, thence North 00 degrees 57 minutes 17 seconds East a distance of 777.26 feet to a steel corner fence post, thence North 89 degrees 53 minutes 57 seconds East a distance of 407.77 feet measured (409.00 feet plat) to an iron pipe at a corner fence post, thence North 00 degrees 51 minutes 38 seconds West a distance of 1477.13 feet measured (1478.00 feet plat) to the true point of beginning. Said tract contains 34.313 acres, more or less, all in the County of Menard, State of Illinois.

Basis of bearing is South 89 degrees 31 minutes 46 seconds East along the section line.
